## Membership BC Orion

### Membership fee

Cost for membership are as listed below:

Adult	€ 22,50 monthly
Youth (under age of 18)	€ 19,50 monthly
Registration at Badminton Nederland Bond	€ 22,50 once at registration only

Every member has the right to play competition. The related cost are not included in the monthly fee. Additional charges are as listed below:

Season	2025 / 2026
Youth competition	free of charge
Recreational competition	€ 7,50 yearly
Regional competition	€ 60,00 yearly
Usage of feather shuttles	€ 85,00 yearly for competition players € 40,00 yearly for recreational players

### Dutch Badminton Association (Badminton Bond Nederland)

Every member of BC Orion is obliged to become a member of the Dutch Badminton Association. For registration a one time fee needs to be payed to the Association. Further the Association collects a yearly fee for each member. These financial obligations are taken and paid by BC Orion to the Association. After processing of your registration form you will receive your digital membership licence sent to you by the Dutch Badminton Association.

### SEPA Euro-incasso

The membership fee is collected every three months ahead by automatic collection from your bank account after signing page 1 of this form. The one-time registration fee shall be collected at the next month after processing your registration. The collection moments are listed below:

September	fee for playing competition (if applicable)
October	fee for playing feather shuttles (if applicable)

However please contact our administration first, because the bank will charge extra cost to BC Orion for cancelation of collections.
